**URANIUM INTERNATIONAL CORP. ENTERS INTO FORMAL OPTION  
AGREEMENT WITH GEOFORUM SCANDINAVIA AB FOR MINERAL LEASES ON  
FOUR URANIUM PROPERTIES IN SWEDEN**

DENVER, CO, Nov. 12, 2009 - Uranium International Corp. ("Uranium International") (OTCBB: URNI) has entered into a formal Option Agreement with Geoforum Scandinavia AB, (the "Optionor") for exclusive options to acquire a 100% interest in four mineral properties in Sweden, subject to a 3% NSR royalty .

According to the terms of the Option Agreement, Uranium International will acquire a lease option in the Laisbäck Property, the Sil ("Pustaberget") Property, the Långträsk Property, and the Rävaberget Property (collectively called the "Properties") located in the Kingdom of Sweden, including all rights, licenses, and permits.

The properties are characterized by available data as having been drilled by government agencies and found to contain uranium mineralization. Any such mineralization has not yet been classified under National Instrument 43-101 guidelines. The management is aware of 92 drill holes completed on these properties.

Under the terms of the Option Agreement, in order to exercise the Option, Uranium International must:

- (a) pay the Optionor \$25,000 at the date of execution of the agreement, and \$25,000 per year until the Option is exercised;
- (b) issue to the Optionor a total of 100,000 shares of Uranium International; and
- (c) incur exploration expense of USD \$3.7 million

Sweden has been increasingly amenable to resource mining and provides a positive outlook on its uranium mining industry. The country has endorsed the fueling of its nuclear reactors and is encouraging the mining of its resources at the highest levels of government. The management of Uranium International is confident that the climate for resource development there will help to expedite this uranium exploration project into a verifiable resource.
